

Visiting the Middle States Commission on Higher Education

The Middle States Commission on Higher Education is located at 3624 Market Street, in Philadelphia's University City Science Center complex. The building has restricted access. You will need to stop at the security station in the main lobby and obtain a visitor's pass. You will then proceed to the second floor. If you are visiting on official business, the receptionist will buzz you into the premises and will then either guide you to the conference room where your meeting is scheduled, or will contact the person you are planning to meet so he/she can come out front to greet you.

How to Reach the Offices of the Middle States Commission on Higher Education

Automobile

Via the Benjamin Franklin Bridge

Upon crossing the bridge into Philadelphia, proceed on the Vine Street Expressway (I-676) westbound to the Schuylkill Expressway (I-76). Proceed eastbound (toward Philadelphia International Airport) for less than one mile to the Market Street exit. Proceed westbound on Market Street for approximately six blocks to 3624 Market Street. The building will be on your left. A parking garage will be on your right.

Via the Walt Whitman Bridge

Upon crossing the bridge into Philadelphia, proceed straight onto the Schuylkill Expressway (I-76). Exit at Market Street and proceed westbound for six blocks to 3624 Market Street. The building will be on your left. A parking garage will be on your right.

Via the Delaware Expressway (I-95)

From the South...

After passing Philadelphia International Airport, follow the signs to "I-76 Valley Forge." Proceed westbound to the Market Street exit. Proceed westbound for six blocks on Market Street to 3624 Market Street. The building will be on your left. A parking garage will be on your right.

From the North...

Exit at Vine Street (I-676) and proceed westbound to the Schuylkill Expressway (I-76). Proceed eastbound on I-76 (toward Philadelphia International Airport) for less than one mile to the Market Street exit. Proceed on Market Street for six blocks to 3624 Market Street. The building will be on your left. A parking garage will be on your right.

Via the Schuylkill Expressway (I-76)

Exit at Market Street. Proceed westbound for six blocks to 3624 Market Street. The building will be on your left. A parking garage is on the right.

Via the Pennsylvania Turnpike

Use exit 326 (Valley Forge) and follow the signs to I-76 East, the Schuylkill Expressway. Proceed on I-76 to the Market Street exit in Philadelphia. Follow Market Street westbound for six blocks to 3624 Market Street. The building will be on your left. A parking garage will be on your right.

There are ample parking garages near the Commission offices. There is a garage directly across Market Street from the Commission offices. An additional garage is located on 36th Street, adjacent to the Sheraton University City Hotel. Parking averages \$20-\$25 per day.

Air

Fly the airline of your choice to Philadelphia International Airport. From the airport, you can board SEPTA's Regional Rail service to 30th Street Station. After exiting the station, walk six blocks west to 3624 Market Street. Taxis are available curbside for the short ride. You can also board SEPTA's Market-Frankford subway line (Blue line) across the street from the train station. Take the subway westbound to the next stop, 34th Street. Exit the station and proceed 2-1/2 blocks west to 3624 Market Street.

Another option from the airport is an approximately nine mile taxi ride to 3624 Market Street.

Amtrak and SEPTA Regional Rail Lines

Take any Amtrak or SEPTA Regional Rail train to Philadelphia's 30th Street Station. After exiting the station, walk six blocks west to 3624 Market Street. Taxis are available curbside for the short ride. You can also board SEPTA's Market-Frankford subway line (Blue line) across the street from the train station. Take the subway westbound to the next stop, 34th Street. Exit the station and proceed 2-1/2 blocks west to 3624 Market Street.

Greyhound Bus

Take the bus to Greyhound's Center City terminal at 10th and Filbert Streets. From there you can board a taxi for the short ride to 3624 Market Street or walk two blocks to the 11th and Market Street station of SEPTA's Market-Frankford subway line (Blue line). Take the subway westbound to 34th Street. After exiting the station, walk 2-1/2 blocks to 3624 Market Street.

Subway

Take SEPTA's Market-Frankford line (Blue line) westbound to 34th Street. Proceed 2-1/2 blocks west on Market Street to 3624 Market Street.

Trolley

SEPTA's Route 10 Subway-Surface trolley line stops on the corner of 36th and Market Streets. After exiting the trolley, proceed one-half block west to 3624 Market Street.

PATCO Hi-Speed Line (from South Jersey)

Take PATCO to the 8th and Market station in Philadelphia. Go upstairs and transfer to SEPTA's Market-Frankford subway (Blue line) westbound. Proceed to the 34th Street stop. Exit the subway and walk 2-1/2 blocks west to 3624 Market Street.
